The VMCC - Cotswold Section is pleased to announce the third running of this event for woefully under-powered machines, to take place yet again on Gloucestershire's flatlands.

Description

The run will be based at The Bell, Frampton-on-Severn (map ref. 748 083, sheet 162) and starts at 10.00am.

The pub car-park will be open from 9.00am and a route card will be issued for the morning run of about 25 miles returning to The Bell for lunch where the riders will meet participants from the Cotswold Section Summer Meeting. (Lunches can be ordered by 10.00am) There will then be an afternoon run of about 15 miles for those who feel fit enough, starting at about 1.30pm.

Participants are expected to bring out machines which have lain unloved at the back of their sheds so that others can admire the craftsmanship and sales talk of a long forgotten past which encouraged people to buy such machines and struggle to reach destinations. Although the route is planned to not contain slopes of more than one in a thousand, it is expected that all riders will display the vulgar arts of pedalling, legging and walking alongside their machines so that all may be congratulated on getting around the course.

A breakdown service will be available.

The spirit of the event dictates that there will be no one winner, rather, all participants will have shown a winning mentality.

To keep this event as friendly as other Cotswold Section events, there will be a limit of 25 riders. Please note that entry is restricted to VMCC and ACU-affiliated members only, riding eligible machines.

Legal Requirements

All participants and machines must comply with all legal requirements, including the display of a valid road fund licence.
